Project Overview

Broadband Acceleration Grant: Connecting Kansans to opportunity

The Broadband Acceleration Grant Program seeks to invest \$5 million towards bridging the digital divide in Kansas. The program can pay up to 50% of the eligible costs for a qualifying project, up to \$1 million, to fund projects that provide access to high-quality, reliable broadband throughout Kansas with priority given to applications that address unserved areas, economically distressed communities and areas of compelling need.

DLS Enterprise's project will be to deploy Fiber To The Home (FTTH) in 4 rural communities (Argonia, Norwich, Milton, Suppesville), in 3 separate counties of southern Kansas (Kingman, Harper & Sumner) as well to deploy fiber in the rural areas of all three counties along the way. The plan will to bring a broadband connection from Rural Harper Co. to Argonia, build FTTH in Argonia, deploy fiber out of Argonia, going north on Argonia Road, toward Norwich taking a rural route to encompass as many rural homes, farms and business along the way, connecting homes and businesses in Milton, Suppesville and landing in Norwich to build FTTH for a completion on or before the deadline. DLSE has seen a need in the communities and wants to help bridge the digital divide in the well under-served areas that we are identifying.

Our organization has identified it as an underserved area for the lack of broadband capabilities that are currently supplied. We have had some outreach from the communities as well as businesses with support for this project to happen. We feel as though this is unlikely to be served without grant funding due to the lack of interest in the current internet providers within these areas. Flexibility in infrastructure paths will be paramount as we consider the service to those along the initial project route. Rural residences will be included in this project.

The population in all 4 communities, is relatively small which makes this build slightly unattractive to larger broadband companies and put such communities at a disadvantage to get such services deployed.

\$94.95 100 Mbps (download) 25 Mbps (upload)
