
Kansas Broadband Acceleration Grant: Public Comment

January 29, 2021 Application: SCTelcom - Pratt County 2

IdeaTek submits this information in response to SCTelcom's Pratt County 2 proposal to the January 2021 Broadband Acceleration Grant.

We are providing a *positive* public comment to this application for the following reasons:

- 1. We believe that fiber optic infrastructure investment is the only scalable, long-term infrastructure investment that currently is available to stop the cycle of "catching up and falling behind" that occurs in rural broadband infrastructure through investments in fixed wireless or satellite broadband.
- 2. We also believe that fiber fed fixed wireless internet deployment is a reasonable short term investment when fiber investments cannot be obtained.
- 3. While our CERG Grant #54 does cover a significant portion of this proposed fiber investment, our grant provided fixed wireless service in this area and it does not cover the entire application service area or fully address the factors noted above for fiber investment.
