ATT fiber stopped 2 houses away from us and came down a road that only serviced one house from county road 5 to 187th St. We currently have approximately 20 houses that ATT fiber didn't connect to. It stopped at 179th and Donahoo Road. It didn't come down 179th St. to Leavenworth Road. The box that ATT fiber put up can serve over 200 homes but is currently only serving about 10 according to the ATT engineer that was working on the box. My husband works from home, and I am a teacher who also at times works from home. My son is in medical school and my daughter is in college. They have lots of classes that are online that goes in and out at times. Our internet is not for the future but for the past. Please consider the houses along this road.**
