Eagle Broadband Investments, LLC dba Vyve Broadband currently has a fiber PON located in the core of Atwood, KS that provides symmetrical gigabit service to homes and businesses. Please find attached a shapefile of our existing service footprint, a point shapefile indicating served locations, as well as photographed speed tests evidencing our current level of service. We believe that the use of grant funds towards applicant's project would result in considerable overbuilding. In addition, Vyve has separately submitted a grant application to extend this fiber PON to the remaining ~70% of the town.
