United Communications offers up to 1G/50M internet service to the town of Jetmore over coaxial cable. United Wireless has built out fiber to several anchor institutions in the town of Jetmore and offers up to 1G symmetrical internet service. Several anchor institutions were mentioned by name in this proposal, please be aware that United currently serves all but one of these offices with either fiber internet or robust coaxial internet service.
