**On August 31, 2022 the FCC announced that they are “Ready to Authorize” various RDOF awards including AMG/NextLink’s application for a wireless deployment in Harper County. It is unfortunate that the FCC made this announcement 21 months after the 904 auction closed and after the Capital Project Fund application submission window closed. It is also unfortunate that the technology proposed, and in this case already deployed, by the awardee for Harper County is an inferior product that will provide an inferior customer experience.**

**SCTELCOM in coordination with KanOkla Networks submitted Capital Project Fund (CPF) applications to overbuild the remainder of the AT&T exchanges in Harper County (Anthony, Attica, and Harper) with fiber-to-the-premise technology. Below are several reasons why we feel that the Kansas Department of Commerce should support the applications of SCTELCOM and KanOkla Networks and all other applicants who are in a similar situation with plans to deploy fiber-to-the-premise technology.**

- 1) NextLink’s maximum service level offering in Harper County is 100/10Mbps, which does not meet the minimal service level requirement of the CPF program. Please see the attached documentation supporting this statement.**
- 2) SCTELCOM’s initial service offering for its CPF customers will be 2.5/2.5Mbps. SCTELCOM does not feel that 100/10Mbps is sufficient for today’s users, especially if we experience another pandemic shutdown and education and business is conducted remotely.**
- 3) Wireless is not a viable and scalable long-term technology due to line-of-sight requirements, its tendency to fail in inclement weather, and the limited amount of spectrum available for this purpose.**
- 4) Fiber is a future safe network infrastructure that is readily scalable and capable of practically unlimited bandwidth.**
- 5) The FCC’s approval of wireless technology for RDOF awards is short-sighted, especially after having witnessed wirelesses inadequacies during the pandemic shutdowns of 2020.**
- 6) Finally, it would be imprudent to take on a project of this scope with this level of rurality without financial assistance available from programs like CPF.**

**We appreciate every consideration the Office of Broadband Development gives to this appeal and the applications of SCTELCOM and KanOkla Networks.**
