CSC Holdings, LLC (“Optimum” or “Altice”) appreciates the opportunity to review the applications and provide this comment as part of the review process. Optimum hereby submits comments to Brightspeed’s project proposal for the Kansas Broadband Infrastructure Program in the area of Spring Hill.

Upon review of the application, we have determined that Brightspeed is seeking funding in the Spring Hill area, where Optimum is currently enhancing its existing infrastructure as part of a greater Paola area market upgrade. This upgrade includes Optimum markets in Paola, Spring Hill, Osawatomie, and Louisburg. Presently, Optimum is providing broadband speeds of up to 150 Mbps download and 7.5 Mbps upload in the Spring Hill area, including 1,198 addresses located inside the Brightspeed proposed service area. The Optimum market upgrade is already underway, with plans to be completed within the next 12 months. Upon completion of the project, the portions of the Brightspeed proposed service area that overlap the Optimum service area will no longer be eligible for funding, per the rules and guidance of the Kansas Capital Projects Fund (CPF) Broadband Infrastructure Program. At that time, Optimum will be able to offer customers multiple choices of residential and commercial broadband services with available speeds of up to 940 Mbps download / 35 Mbps upload.
