**CSC Holdings, LLC (“Optimum” or “Altice”) appreciates the opportunity to review the applications and provide this comment as part of the review process. Optimum hereby submits comments to Charter Communications’ project proposal for the Kansas Broadband Infrastructure Program in the area of Louisburg.**

**Upon review of the application, we have determined that Charter Communications is seeking funding in the Louisburg area, where Optimum is currently extending its existing infrastructure as part of a greater Paola area market upgrade. This upgrade includes Optimum markets in Paola, Spring Hill, Osawatomie, and Louisburg. Presently, Optimum is constructing a network in Louisburg to provide broadband speeds of up to 150 Mbps download and 7.5 Mbps upload. Upon completion of the market upgrade next year, those speeds will increase to up to 940 Mbps download / 35 Mbps upload. There are currently 77 service-ready addresses located inside the Charter Communications proposed service area, with the remainder of Louisburg scheduled to be service-ready by the end of this year. The Optimum market upgrade is already underway, with plans to be completed within the next 12 months. Upon completion of the project, per the rules and guidance of the Kansas Capital Projects Fund (CPF) Broadband Infrastructure Program, the addresses in Louisburg will no longer be eligible for funding. At that time, Optimum will be able to offer customers multiple choices of residential and commercial broadband services with available speeds of up to 940 Mbps download / 35 Mbps upload.**
