- ADMINISTER SPARK FUNDS DIRECTED TOWARDS THE KANSAS DEPARTMENT OF COMMERCE FOR STATEWIDE PROGRAMS
- APPLY FOR AND ADMINISTER AMERICAN RESCUE PLAN ACT (ARPA) FUNDING THROUGH THE U.S. ECONOMIC DEVELOPMENT ADMINISTRATION (EDA)
- PROVIDE TECHNICAL ASSISTANCE, SUPPORT, AND GUIDANCE FOR LOCAL, COUNTY, AND REGIONAL APPLICATIONS FOR ARPA-RELATED FUNDING



SPRINT GRANT TIMELINE

Award Announcement 4/3/23 or later 1st Quarterly Report Due 07/31/23 2nd 50% of Award Disbursed by 1/1/24

Final Quarterly Report Due by 4/30/25 Close-out Report due by 07/31/25

1st 50% of Award Disbursed by 06/01/23

2nd Quarterly Report Due by 10/31/23 All Grant Expenditures Due by 4/30/25





FREQUENTLY ASKED QUESTIONS

Q. MY CITY/COUNTY RECEIVED ARPA FUNDS. AM I ELIGIBLE TO

APPLY?

A. CITIES AND COUNTIES RECEIVED LOCAL FISCAL RECOVERY FUNDS

FROM ARPA. ONLY CITIES, COUNTIES, AND ENTITIES THAT

RECEIVED STATE FISCAL RECOVERY FUNDS, SUCH AS THE BASE

GRANT AND HIGHER ED FUNDS, ARE INELIGIBLE FOR SPRINT.



FREQUENTLY ASKED QUESTIONS

Q. IS SAM.GOV REGISTRATION REQUIRED?

A. YES, ALL SUBRECIPIENTS ARE REQUIRED TO HAVE A UNIQUE ENTITY ID

(UEI) AS PART OF REGISTRATION IN ADDITION TO MAINTAINING AN

ACTIVE REGISTRATION IN THE SYSTEM FOR AWARD MANAGEMENT

(SAM) (HTTPS://WWW.SAM.GOV). REGISTRATION IS NOT REQUIRED FOR

AN APPLICATION, BUT IT WILL BE REQUIRED IN ORDER TO RECEIVE AN

AWARD. IF A UEI CANNOT BE OBTAINED PRIOR TO THE APPLICATION

DEADLINE, PLEASE ENTER TBD IN THE REQUIRED FIELD.





FREQUENTLY ASKED QUESTIONS

Q. CAN I USE GRANT FUNDS OR MATCHING FUNDS TO PURCHASE FURNITURE, SMALL EQUIPMENT, OR OTHER EQUIPMENT FOR MY FACILITY?

A. ONLY PERMANENTLY INSTALLED EQUIPMENT, SUCH AS HVAC, PERMANENT

TECHNOLOGY EQUIPMENT, OR OTHER INSTALLED AND PERMANENTLY AFFIXED

EQUIPMENT, MAY BE PERMITTED AS EQUIPMENT PURCHASES. FURNITURE AND

OTHER REMOVABLE EQUIPMENT ARE NOT PERMITTED TO BE USED WITH

GRANT FUNDS.



FREQUENTLY ASKED QUESTIONS

Q. DO I NEED TO GO OUT TO BID TO GET THE ESTIMATES FOR MY APPLICATION?

A. NO. HOWEVER, IF YOU ARE AWARDED A SPRINT GRANT, YOU WILL BE REQUIRED TO COMPETITIVELY PROCURE ANY EXPENSE ON YOUR PROJECT THAT EXCEEDS \$5,000 OR MORE,

UNLESS YOUR ORGANIZATION HAS A STRICTER SPENDING THRESHOLD. AT THAT TIME, WE WILL

NEED TO SEE YOUR PROCUREMENT POLICY, NOTICE OF BID/RFP, THE RESPONSES RECEIVED, A

METHOD OF DETERMINATION, AND THE FINAL CONTRACT FOR ALL SERVICES & VENDORS.



FREQUENTLY ASKED QUESTIONS

Q. WHAT IF I ALREADY HAVE AN ARCHITECT OR ENGINEER ON CONTRACT FOR MY PROJECT? WILL I HAVE TO FIND A NEW ONE FOR THE GRANT?

A. NOT NECESSARILY. IF YOUR EXISTING ARCHITECT/ENGINEER WAS OBTAINED IN A

COMPETITIVE MANNER, YOU WILL BE ALLOWED TO MAINTAIN THAT CONTRACT PROVIDED THE

SCOPE OF WORK INCLUDES YOUR PROJECT REQUEST AND YOU CAN PROVIDE THE SAME

PROCUREMENT INFORMATION WHEN THAT PROVIDER WAS SELECTED. THIS WILL BE APPROVED

ON A CASE-BY-CASE BASIS.



FREQUENTLY ASKED QUESTIONS

Q. CAN MY APPLICATION INCLUDE A REQUEST FOR PURCHASING PROPERTY?

A. YES. HOWEVER, REAL ESTATE PURCHASES (LAND OR BUILDINGS) ARE LIMITED

TO 50% OF THE FULL GRANT REQUEST. FOR EXAMPLE, A GRANT REQUEST OF

\$2,000,000 MAY ONLY BUDGET \$1,000,000 FOR THE PURCHASE OF A BUILDING

OR LAND.



FREQUENTLY ASKED QUESTIONS

Q. CAN I USE PREVIOUSLY ALLOCATED AND EXPENDED FUNDS AS PART OF MY FUNDING REQUEST?

A. APPLICATIONS THAT ARE CONSISTING OF A PROJECT STILL

IN PROGRESS MAY REQUEST FUNDS FOR EXPENDITURES

DATING BACK TO JULY 1, 2022, WITH DOCUMENTED PROOF

OF EXPENSES.



FREQUENTLY ASKED QUESTIONS

Q. WHAT IF I WANT TO RENOVATE AN EXISTING PROPERTY THAT IS ON THE STATE OR NATIONAL HISTORIC REGISTRY?

A. IF YOU ARE SELECTED FOR AN AWARD, YOU WILL NEED TO

OBTAIN WRITTEN PERMISSION FROM THE KANSAS STATE HISTORIC

PRESERVATION OFFICE BEFORE YOU WILL BE ISSUED AN AWARD

AGREEMENT OR ANY FUNDING FROM THIS PROGRAM.



FREQUENTLY ASKED QUESTIONS

Q. AM I REQUIRED TO USE THE BUDGET TEMPLATE PROVIDED ON THE SPRINT GRANT WEBPAGE?

A. NO. YOU WILL BE REQUIRED TO SUBMIT A BUDGET AND TIMELINE

FOR YOUR PROJECT, BUT YOU ARE ABLE TO USE ANY FORMAT THAT

BEST SUITS YOUR PROJECT.



FREQUENTLY ASKED QUESTIONS

Q. ARE CITY AND COUNTY PARKS ELIGIBLE TO APPLY?

A. CITY AND COUNTY ENTITIES MAY APPLY FOR GOVERNMENT OWNED

TOURISM LOCATIONS, BUT LOCAL PARKS ARE NOT ELIGIBLE UNLESS THERE IS A

REGIONAL TOURISM FOCUSED ECONOMIC DEVELOPMENT IN PLACE, SUCH AS A

SPECIFIC TOURIST DESTINATION AND NOT A COMMUNITY

ATTRACTION/FACILITY THAT SERVICES LOCAL MEMBERSHIP (IE: POOL).



FREQUENTLY ASKED QUESTIONS

Q. SHOULD I SUBMIT MULTIPLE PROJECTS OR COMBINE THEM INTO ONE LARGER REQUEST?

A. IT IS RECOMMENDED TO SUBMIT A PROJECT THAT HAS THE LARGEST IMPACT

TO YOUR AREA. IF PROJECTS ARE SIMILAR IN STRUCTURE OR RELATED IN

NATURE, IT WOULD BE BEST TO SUBMIT A COMBINED FUNDING REQUEST.



FREQUENTLY ASKED QUESTIONS

Q. DOES THE GRANT PROVIDE "ALL-OR-NOTHING" FUNDING? CAN MY AWARD BE REDUCED?

A. IF A PORTION OF YOUR PROJECT MAY BE CONSIDERED INELIGIBLE OR IF FUNDS ARE LIMITED IN THE OVERALL PROGRAM, WE CAN STILL AWARD THE

APPLICANT WITH A LESSER AMOUNT OF FUNDING THAN REQUESTED.



FREQUENTLY ASKED QUESTIONS

Q. IS THERE A SCORING MATRIX FOR THE APPLICANTS TO REVIEW?

A. A SCORING MATRIX WILL BE PROVIDED ON THE

KANSASCOMMERCE.GOV/SPRINT WEBPAGE PRIOR TO THE END OF

THE APPLICATION PERIOD.


