The applicant hereby assures and certifies with respect to the grant that:

- 6. The basis for concluding that each Section 104 (d) replacement dwelling unit will remain a low- and moderateincome dwelling unit for at least ten years from the date of initial occupancy.

The jurisdiction will provide relocation assistance, as described in Section 570.488 to each low- and moderateincome household displaced by the demolition of housing or by the conversion of a low- and moderate-income dwelling to another use as a direct result of assisted activities.
