### What is the Kansas State Loan Repayment Program?



The Kansas State Loan Repayment Program (SLRP) offers eligible health care professionals an opportunity to receive assistance with the repayment of qualifying educational loans in exchange for a minimum two-year service commitment.

#### **Eligibility Requirements: Health Care Professional**

#### Be a U.S. Citizen or National

Have a current permanent Kansas Professional License

Work full-time at an approved practice site







#### **Eligible Practice Site Types**

- CMS-Certified Rural Health Clinics (RHC)
- Community Mental Health Facilities
- Community Outpatient Facilities
- Correctional or Detention Facilities
- Critical Access Hospitals (CAH) Affiliated with a Qualified Outpatient Clinic
- Federally Qualified Health Centers (FQHC)
- Federally Qualified Health Center Look-A-Likes (FQHC LAL)
- Free Clinics
- Immigration and Customs Enforcement Health Service Corps
- Indian Health Service Facilities (IHS)
- Mobile Units
- School-Based Clinics
- Solo or Group Private Practices
- State and County Health Department Clinics



### Are you planning to apply?

- Application cycle now open year-round!
- An application must be submitted by the health care professional **and** the health care practice site.





#### **Health Care Practice Site Application**

- Completed Health Care Practice Site Application form for each practice site.
- Copy of health care professional's job description and employment contract.
- Practice site policy on non-discrimination of patients based upon race, color, sex, national origin, disability, religion, age, or sexual orientation.
- Practice site policy for the sliding fee scale discount or financial assistance, and the patient application form for financial assistance.
- Photograph of posted signage of the non-discrimination policy and sliding fee scale/financial assistance policy.
- Practice site proof of access/referral arrangements for ancillary, inpatient and specialty care that is not available on-site (MOUs, MOA, or contracts).
- Recruitment and retention plan and proposal to retain the health care professional up completion of the service obligation.
- Completed Federal W-9 form.

From 2018 to 2022, we helped 59 health care professionals pay off over \$1.3 million in student debt. Of the 59 participants, 16% served a frontier county and 44% served in a rural county.

### **CBPCC – Community-Based Primary Care Clinic Program**

- Available Funds: \$13 Million

  - The Community-based Primary Care Clinic (CBPCC) program assists clinics in improving access to quality health care with an emphasis on community-based services and reducing health disparities for underserved populations.
  - Grant funds are intended to make primary medical and dental care, prescription drugs, and preventive health care services accessible and affordable to underserved Kansas residents, including uninsured individuals and those enrolled in public insurance programs that are operated by the State of Kansas and/or federal government with eligibility based on income (KanCare).

### **Kansas Community Funding Opportunities**

#### **RHIG – Rural Hospital Innovation Grant**

- Available Funds: \$10 Million
  - The purpose of RHIG is to strengthen and improve the health care system and increase access to health care services in eligible counties in order to help communities in those counties achieve and maintain their optimal health.
  - Funds are to be used at a hospital within the county for the transitional assistance related to changing a hospital's current health care delivery model to a model more appropriate for the community that the hospital serves.
