Comments relating to Requirement 5: Identification of existing unserved and underserved broadband locations We currently have internet through the phone lines. Yes, these are two regular old phone wires just like the 56k modem ones from the 90's running from the telephone post. I know this is almost completely unbelieveable these days, but it is true. The only landline provider that is available here is Brightspeed. Apparently Brightspeed and Verizon satellite "own" the rights to this area and no one else is allowed to sell internet in this location. I have called every company around for many years and have always been denied service, even if they claim to have service in our area. If you call them they will not actually sell it. They tell us they are "not allowed" to provide us internet in this location. A specific complaint is that DirectTV can sell us television, but are not allowed to provide internet through the exact same cables. Previous satellite internet from Verizon was unbelieveably expensive, worse service than these phone lines, constantly lost connection, was extremely limited (not enough data to even download one piece of purchased software without incurring overage charges) and had very serious lag. It was completely unusable. We resorted to phone line internet, and have had it ever since.
