Comments relating to Requirement 3: Identification of existing broadband efforts We applied for a Broadband grant through Nex-Tech to improve broadband/internet access in the rural part of the county. However, our application was vetoed by Vyve and Dunkers, who claimed that they have no viable plan to extend broadband coverage to these underserved areas, leaving the community without a reliable solution for improved connectivity.

Comments relating to Requirement 5: Identification of existing unserved and underserved broadband locations Identification of existing unserved and underserved broadband locations is a critical step in understanding the extent of the digital divide in the region spanning from the county borders of Decatur to Thomas to Cheyenne County. Accurate data on these areas will inform targeted efforts to bridge the gap and provide reliable broadband access to underserved communities.

Comments relating to Requirement 7: Detailed BEAD challenge process The Broadband Economic Assistance and Development (BEAD) challenge process in Rawlins County aims to address the lack of broadband access in underserved areas. However, Vyve, the existing service provider, is having residential customers falsely claim to be businesses to try to qualify for broadband services. Moreover, Vyve's service reliability has declined, leaving residents frustrated, and local internet companies are unable to provide broadband due to uncertainties in partnering with Vyve. These challenges pose significant obstacles to achieving widespread broadband coverage in the county.
