# Rural Prosperity in Kansas — ORP Funding Rural Murals — Currently open

Closes May 1st for point bonus – May 10<sup>th</sup> otherwise

#### **INTENT:**

To activate vacant and underused spaces through the arts to help bring together community members around the art, history, and culture of the community.

#### **DESCRIPTION:**

This program provides funding for communities with populations of 15,000 or less to create new murals or public art that incorporates the community's history, culture, heritage, tourism, or other community led art piece. This mural and public art grant program is intended to support projects in rural communities that are immediately ready to begin work on their mural, with community engagement, location selection, site approvals, and muralist selection being completed by May 10 2024





#### **Eligible Applicants-**

- Communities with a population of 15,000 or less, located in a county of 50,000 or less
- Units of local government
- Economic/Community Development, Chamber and Tourism non-profits (501c3 or 501c6)
- Federally recognized tribes
- Non-profit organizations (501c3)

#### **Match Requirement -**

- Dollar for dollar (1:1)
- The total project cost must be at least twice the amount of the grant request.
- The match requirement must consist of at least 25% cash expenses provided by the applicant
- In-kind non-monetary donations and volunteer hours may be counted, up to 75% of the required match

#### **Match Exception -**

- Organizations or projects in communities with populations of 1,000 or fewer:
  - o In-kind, non-monetary donations may be counted as 100% of the required match

### Maximum Request- \$7,500





#### **Funding Priorities -**

- Communities or Counties that have not previously received funding from the Kansas Department of Commerce for murals or public art
- Projects that can show that they are ready to begin. This means that the
  community engagement phase is complete, muralist has been identified and they
  are available, and that the location of the mural has been identified and approvals
  given to put the mural on the wall.
- Projects that can be completed by December 31, 2024, or if they will be painted
  on an exterior wall, that the project will be completed before mid-October.
- Murals or public art that is done collaboratively across the county or as a region to celebrate their history or culture as a Kansas community





#### **Grant Timeline -**

February 23, 2024 - Spring 2024 ORP Rural Mural Grant Opens

May 1, 2024 – Priority Scoring given to submitted projects

May 10, 2024 - Spring 2024 ORP Rural Mural Grant Closes (12 weeks)

Early June- Awards Announced – Projects can begin upon award notification

Late June - Grant Award Payments issued

#### Performance Period

- June 2024 December 31, 2024
- Murals painted on exterior walls using paint or an adhesive material need to be completed by October 2024
  to ensure weather does not inhibit the curing process.
- If more time is needed to complete your project, KCAIC has an additional program that could be a better fit.





## Rural Prosperity in Kansas – ORP Funding

#### **#RuralbyChoice Champions**

- Provides funding for the Champion for 1 year to tackle an identified community need (\$20/hr, 20 hrs/wk = \$20,800\\$5,200 quarterly)
- Reimbursement grant for wages
- Match requirement 25%- can include in-kind, but must include some cash
- Selected projects also receive \$25,000 implementation grants, implementation plan to be developed by Champion
- Kansas Leadership Center training provided through Transformation grant
- In 2023, 12 champions tackled projects like Housing, Childcare, Economic Development, Trails/Wellness, Community Development and community vitality
- 2<sup>nd</sup> round opening late April 2024





# Rural Prosperity in Kansas — ORP Funding HEAL – Building or Façade Grants

- Downtown or downtown corridor historic building rehabilitation or Façade rehabilitation
- \$100,000 maximum per award
- 1:1 CASH match required by building owner, community, or any other source
- Must include plan for business to occupy space at project completion
- 2-year timeline for completion (does not include demo)
- Opens again June 3, 2024
- Grant awards to be announced in October


#### **Emergency HEAL – Building Grants**

- Downtown or downtown corridor historic building rehabilitation or Façade rehabilitation
- \$100,000 maximum per award
- 1:1 CASH match required by building owner, community, or any other source
- Can cover more than one building
- 2-year timeline for completion (does not include demo)
- Rolling Deadline Open NOW!
- Grant awards to be announced within one month of application submission date













## Successes Building Statewide




### 2023 ROZ Participation Map















## Rural Opportunity Zone Program

#### Student Loan Repayment- How it works:

- Each qualifying participant may receive up to \$15,000 from the state and a local sponsor over 5 years to help pay for their student loans. (\$3,000/year)
- KDC and the local sponsor will split the award amount and pay it each year.
- Recent changes ensure that program can be used to incentivize rural students to return home after college
- Each participant must have a local sponsor to receive payments; this can be a county, city, foundation or employer.
- Maximum sponsor payment annually is \$1,500 per participant.





## Rural Opportunity Zone Program

#### How it can be used locally:

- ROZ can be a useful workforce recruitment tool for employers and economic developers. It's an incentive that isn't a one-time lump sum, but a 5-year long program that encourages new residents to stay and engage in their community.
- ROZ can help fill critical jobs for your region and high-demand occupations that require higher education.
- Critical jobs differ from region to region –with ROZ, you can tailor your recruitment efforts towards specific industries by encouraging employers and foundations to become sponsors.
- County and City Economic Development professionals can use the program to recruit new residents.
- Real estate agents can refer the program to potential homebuyers looking in their area as an additional incentive to move to certain areas (and purchase their listing of course!)
- KDC has <u>marketing materials</u> available to help promote the program, and we can also develop more individually tailored materials to fit your needs.



**Low- to Moderate-Income Neighborhoods** 







# Community Development Block Grants (CDBG)

The CDBG program provides funding for projects that help low- to moderate-income neighborhoods thrive. Projects range from sidewalks to community centers, youth job training programs, and much more.

#### **Funding**

- Approximately \$14.5 million annually
- Funding is prioritized for areas of need in Kansas
- Only cities/counties can apply for CDBG
- Projects must meet one of three National Objectives
- (1) LMI Percentage
- (2) Slum and Blight
- (3) Urgent Need



## Spaces to Places Placemaking Pilot

Placemaking is the activation and reimagining of public spaces in communities.

Spaces to Places supports community-led projects that create, revitalize, or activate public spaces to bring people together to improve their quality of place. Community Development staff engage cross-sector stakeholders, conduct an assessment of public spaces, and create an action plan.



# COMMUNITY SERVICE PROGRAM (CSP) TAX CREDITS

Amplifying fundraising activities for non-profits.







#### Community Service Program (CSP) Tax Credits

Allows private, non-profit organizations and public health care entities to improve their ability to undertake significant capital campaigns for projects involving community improvements, children and family services, nongovernmental crime prevention, youth job training, and health care.

#### **Funding**

- Approximately \$4.5 million annually
- Organizations can request up to \$200,000
- Projects must be new and one-time in nature

Applications are open now and close on April 31, 2024

State tax credits reduce the total amount of taxes owed to the state. They are a way for a taxpayer to substantially reduce the cost of contributing to a charitable organization. These credits are refundable AND transferable.

# Startup Housing Opportunity Venture Loan (SHOVL)

The goal of SHOVL is to provide funding to developers for expenses incurred prior to the closing of their permanent financing for housing developments. The housing developments must have a direct connection to past, current or future economic development efforts.

Communities under 10,000 population only.


