

ROSTER ARTIST INCLUSION SCORING RUBRIC

Applications are reviewed by a peer review panel consisting of professionals with broad knowledge in the arts, community and economic development, and a chair who shall be a member of the KAC staff or commission.

APPLICATION REVIEW CRITERIA

- Artistic Quality:** Artistic excellence and merit of the applicant and quality of services. This is the primary consideration for inclusion in the roster.
- Capability and Experience:** Evidence of experience and reliability. Ability of applicant for effective implementation, management, and promotion of programs.
- Impact:** Ability of applicant to impact the host community through programming activities will be considered.

Within each criterion, benchmark descriptions and corresponding point values are listed to serve as a guide in the scoring process. During the Panel Review meeting, panelists will indicate scores.
