KANSAS COMMUNITY EMPOWERMENT (KCE)

On July 1, 2025, Lieutenant Governor and Secretary of Commerce David Toland announced that the Kansas Department of Commerce officially assumed administration of the Kansas Community Empowerment (KCE) program.

Previously managed by K-State Extension, KCE has long stood as a cornerstone of grassroots community development in Kansas.









KCE Listening Tour

(July – September)

65 communities visited in 49 days

Main Takeaways

- More communication and in-person support
- Clearly defined structure and expectations
- More trainings
- Simpler reporting
- Access to larger grants
- Desire for connection, networking, and peer learning
- Need for visibility and recognition
- Branding confusion and desire for name refinement







DRAFT CERTIFICATION PROCESS OVERVIEW







Program Requirements

(Applies to All Communities)

- Operates separately from the city/county government but may be associated. The program is designed to support volunteer efforts, not government efforts.
 - If a program is associated with a city or county government, external members are highly encouraged. They are required for Communities of Excellence.
- Each community group must have a mission and vision statement.
- All communities must submit a report twice per calendar year, plus required grant-specific reports.
- Annual Enrollment period: July 1 August 31 each year.
- Commerce will evaluate participation levels on an annual basis. Communities that do not fulfill each requirement may have their requested level adjusted.

COMMUNITIES OF GROWTH

- Minimum of 3 dedicated volunteers.
- At least 1 annual goal.
- At least 1 annual meeting.
- Community Assessment Tool: Recommended every 3-5 years, not required.
- Reporting twice per calendar year.





COMMUNITIES OF GROWTH

Participation Benefits:

- Eligible for Spark Grants.
- Invited to KCE Summit day activities.
- Invited to Pop-up events.
- Access to resources and trainings.







COMMUNITIES OF ACTION

- Minimum of 5 dedicated volunteers.
- At least 3 annual goals.
- At least 2 annual meetings.
- Community Assessment Tool: Must be completed within 6 months and updated every 5 years.
- Continuously evaluate community needs and implement projects.
 - At least 1 annual project with a minimum value of \$500. KCE grants cannot fund the project, but other grants can be utilized and in-kind donations and services can cover 100% of the project.
- Reporting twice per calendar year.







COMMUNITIES OF ACTION

Participation Benefits:

- Eligible for Spark Grants.
- Eligible to host board meetings and pop-ups.
- Invited to KCE Summit day activities).
- Access to resources and trainings.







COMMUNITIES OF EXCELLENCE

- Minimum of 5 dedicated volunteers for communities smaller than 1,500.
- Minimum of 10 dedicated volunteers for communities larger than 1,500.
- If the group is associated with a government entity, at least 2 external members not associated with the government are required.
- Have at least 5 annual goals and quarterly meetings.
- Community Assessment Tool: Must be completed within 6 months and updated every 3 years.
- Continuously evaluate community needs and implement projects.
 - At least 1 annual project with a minimum value of \$1,000. KCE grants cannot fund the project, but other grants can be utilized and in-kind donations and services can cover 100% of the project.
- Reporting twice per calendar year.



COMMUNITIES OF EXCELLENCE

Participation Benefits:

- Eligible for Spark and Impact Grants.
- Invited to KCE Summit + evening reception.
- Eligible to host board meetings and popups.
- Eligible to be featured in a Community Impact Tour.
- Access to resources and trainings.







KCE GRANTS

\$125,000 Total Funding Available in 2026

COMMUNITY SPARK GRANTS

\$500 – \$5,000 (All levels eligible)

COMMUNITY IMPACT GRANTS

\$5,000 - \$15,000 (Excellence only)

Grant Cycles (2 Rounds)

Round 1: January 1 – February 28, 2026

Round 2: September 1 - October 31, 2026
