

# **Project Summary** -

Perfect Fit's DRAW initiative included expanding workforce training capacity in by investing in third-party training and in-house supervision for behavioral health professionals. This project addressed a critical shortage of qualified therapists and technicians in the region, particularly those trained to serve individuals with autism and other developmental disabilities.

#### **Grantee Information**

Founded in 2019, Perfect Fit Foundation of SWK is the only Applied Behavioral Analysis clinic in southwest Kansas. Perfect Fit works to increase acceptance and awareness of children with Autism or a behavioral need utilizing a multidisciplinary therapeutic approach. They ensure that every individual, regardless of disability, receives equal opportunities, services, and acceptance.

# **Goals and Objectives**

**Goal:** Expand the behavioral health workforce in SWK by increasing the number of trained professionals capable of delivering multidisciplinary therapy services.

**Objective:** Recruit and train new behavioral health professionals, including Registered Behavior Technicians (RBTs) and Board Certified Behavior Analyst (BCBAs).

**Objective:** Acquire specialized equipment and technology to support hands-on training.

**Objective:** Support supervision to guide trainees and ensure quality standards in service delivery.

**2025** - 7 new behavior technicians hired

and trained

## Outcomes -

- 7 new staff hired and trained in ABA, increasing therapy availability for underserved populations in rural Kansas.
- Established a sustainable pipeline for workforce development to reduce turnover and improve retention in the behavioral health sector.
